Privacy Policy (Interim)

Handball Australia is committed to protecting the privacy and security of the personal information of our members, participants, volunteers, and other stakeholders. This Privacy Policy outlines how we collect, use, disclose, and safeguard your personal information. By accessing or using our services, you consent to the practices described in this Privacy Policy.

1. Information We Collect

We may collect the following types of personal information:

- Contact information (such as name, address, email address, and phone number)
- Date of birth and age
- Gender
- Emergency contact details
- Membership information
- Payment information (such as credit card details)
- Participation and performance data
- Photos and videos taken during events or activities
- Any other information provided voluntarily

2. How We Use Your Information

We use your personal information for the following purposes to:

- provide and manage our services and programs
- communicate with you regarding events, activities, and updates
- process memberships, registrations, and payments
- ensure the safety and security of participants during events
- comply with legal obligations
- improve our programs and services
- promote Handball Australia sanctioned events and activities (with your consent)
- to support the development of the sport through other purpose you have consented to, including contact from future sponsors.

3. Disclosure of Your Information

We may share your personal information as:

- details of emergency contacts and submitted details for emergency medical services in case of a medical emergency
- details for law enforcement or regulatory authorities when required by law

4. Data Security

We employ reasonable technical and organisational measures to protect your personal information from unauthorised access, disclosure, alteration, and destruction.

5. Choices

You can choose not to provide certain information, but it may limit your ability to participate in our events and activities. You can also update or delete your personal information by contacting us.

6. Cookies and Tracking

We may use cookies and similar tracking technologies to enhance your experience on our website. You can adjust your browser settings to disable cookies, but this may affect your ability to access certain features on our website.

7. Safeguarding information of Children and Young People

We adhere to Australia privacy requirements around the collection and storage of information around Children and Young People participating in our programs and representing our organisation, requiring any communication and permission at all times from their guardians. Handball Australia adopted the National Integrity Framework (NIF) policies on Child Safeguarding Policy in full. If you believe we have inadvertently collected information from a child or young person, please contact us, and we will promptly remove the information.
